Political Action Chair's Report II Shawn Harmsen

Greetings my fellow COGS members!

I hope you are all adjusting well to the new semester! If you are new, you should be noticing your first paychecks and be registered for health benefits (fingers crossed you won't need those!). Did you know that this benefit package is the 2nd best in the Big 10, and just a few years ago before COGS got started here at Iowa it was ranked around the bottom? All of us graduate students owe a debt of gratitude to those who have worked diligently over the years to negotiate a livable wage and humane health care, spending huge amounts of personal time and energy to do so.

You may be wondering why the political action chair is talking about contract negotiations. It's simple. If we aren't careful about Iowa state politics, we will lose the ability to even bargain in the first place. COGS is not a partisan organization, and that is proper and should be respected. Yet it is worth noting that the partisans themselves have settled out quite clearly along party lines, with the Republican party stripping collective bargaining rights from our fellow graduate students in places like Wisconsin and Michigan, and nearly here in Iowa. In March of 2011, the GOP controlled Iowa House passed a bill, on party lines, that would have destroyed collective bargaining. It was defeated along party lines in the Democrat controlled Iowa Senate. But it's a narrow margin. Democrats currently have a two member advantage in the Senate. And if only seat is lost, it becomes a tie to be decided by what is currently a Republican Lt. Governor. So what can we do about this?

I am not going to tell you which party or which candidates for whom you should vote. Instead I am going to be doing my best to promote three goals and I hope you will join me in this effort. They are first to get COGS members registered to vote locally (if possible), second to get members informed, and third to get COGS members involved! Coming up in January, Iowa will once again hold its caucuses (this happens every two years). If you are registered to vote locally and have declared a party, you may attend your precinct caucus, and you may have a voice in the selection of candidates and issues. If you are reluctant to declare a party, remember you can still vote for whomever you like come November. But by declaring and getting involved, you will get a fairly unique opportunity to get your political voice heard.

As we get closer to January, I will supply more information, and hopefully opportunities to meet with political candidates so you can evaluate them face-to-face.
